## **Directions to Kahn Ranch:**

From Hwy 1, go east on Carmel Valley Rd. for 11.8 miles to Esquiline Rd. Turn right on Esquiline Rd., go .6 miles. Turn right on Southbank Rd., go .8 miles. Go left at Hitchcock Rd., go .6 miles to Kahn Ranch entrance & parking area.

Note: Esquiline Rd. is 2.2 miles east of Laureles Grade.

Please be courteous and respect all property and persons. Refrain from loud noise and disruptions to the peace and tranquility of parklands neighbors. Please review and abide by the following conditions when accessing Kahn Ranch:

- Public access to the Kahn Ranch via Hitchcock Road is 7 days a week, during daylight hours. Only 10 vehicles per day may access the Hitchcock Road entrance.
- When accessing Kahn Ranch via Hitchcock Road, all visitors must sign in at the check-in station located at the parking area.
- Bicyclists are not allowed on Hitchcock Road at any time, but may access and leave the Kahn Ranch via Hitchcock Road when transported by a permitted vehicle on a permitted day. Bicyclists must wear helmets when riding.
- Hikers and equestrians and horse trailers are not allowed on Hitchcock Road at any time.
- Due to the limited number of permits available, only 2 permits per month will be issued per individual. However, additional permits may be granted on a space available basis no more than 48 hours prior to a requested permit date.
- Permits will be issued up to 30 days in advance of the requested permit date.
- Permit applications should be submitted no less than 48 hours in advance of permit date requested. Applications submitted less than 48 hours in advance will be given consideration, but cannot be guaranteed to be processed in time for the requested permit date.
- Carpooling is strongly encouraged due to parking space limitations.
- Parking is limited to 10 spaces. Any vehicle without a properly displayed valid parking permit will be cited and may be towed at the owner's expense. Vehicles left in the parking area after the posted closure hour will be cited and may be towed at the owner's expense.
- A copy of the access permit is to be kept with the permittee.
- Alternative access for hikers and equestrians is unrestricted if entering and exiting the Kahn Ranch from the Vasquez-Cougar Ridge trails within Garland Ranch Regional Park.
- Emergencies should be reported by calling 911. For District staff, please call (831) 372-3196 ext. 101, or the Ranger Station at (831) 659-4488.
- Commercial group use will not be licensed or permitted.
- The District and adjacent property owners own the Hitchcock Road right-of-way. Visitors agree to hold harmless and indemnify the District and adjacent property owners from any claims, damages, injuries, losses, or liabilities arising out of visitor's use of said right-of-way.
